490.1 Allotments Cllr Harbutt 490.1.1 The boundary of the Parish land at the Rattlesden Road site is poorly defined although clearly delineated in places by original fence posts. A budget will be needed next year if there is to be reinstatement of a post & wire fence on the boundary line. Similarly, there is need for refurbishment of the rabbit proof fencing which might well require upgrading to deal with recent incursions of muntiac deer. The water leak at the Gedding Road site, the result of a 490.1.2

corroded tap, has been dealt with as previously authorised.
