Planning applications as notified by MSDC for comment:

11.01 DC/18/01268 Outline Planning Permission (with all matters reserved) — Erection of 2 No. detached bungalows.

Land on the north side of Shortgate, Beyton road, Drinkstone

Councillors objected to this application for the following reasons:

- The site is in the countryside. It is outside of the settlement boundary of a 'countryside village'. Both of these factors combine to make an undeniable case against the proposed development.
- Tested against NPPF, the case for this proposal falls when the adverse impacts are weighed against the benefits, assessed against the policies within the Framework as a whole regarding sustainable development.
- Councillors take it that the three NPPF dimensions of sustainable development should not be taken in isolation, but that any gains should be sought jointly towards the Framework aspiration of 'seeking positive improvements in the quality of the built, natural and historic environment as well as in people's quality of life.'

- Given the absence of any commercial infrastructure in Drinkstone by way of shops or services, economic gain can only accrue by way of the very short-term build-out period when there is the possibility of the employment of local construction trades workers.
- Given the lack of any assessed support for more housing of the type proposed, Councillors rely on local knowledge to confirm that there would be no resultant social benefit.
- The environmental impact would be seriously adverse. The limited resources afforded in Woolpit are 4 miles distant. There is no pedestrian path along the unlit winding rural roads which have limited forward visibility making cycling hazardous. The fact that a bus service is 'regular' does not offer any useful amelioration:
 - 6.1 Of the 4 daily buses to Bury St Edmunds, just 1 offers the possibility of timings that would allow commuting should those timings coincide with work patterns i.e. depart at 07.22, return at 18.30.
 - 6.2 The bus to Woolpit runs on Fridays only and is a privately operated service which could cease at any time. It covers the 4 miles in 55 minutes as a result of diverting via other rural locations.
- The inevitability of extra car use, should this application succeed, runs counter to the NPPF central objective of sustainability. Further, the current development pressure at Woolpit impose an uplift in housing stock of several hundred dwellings which will place great strain on the available parking and tend to divert traffic seeking retail and other services further afield.
- The impact on the street scene of modern bungalows in this very rural location and in the context of a strong Suffolk rural vernacular would be much to the detriment of the amenity of the neighborhood.

- 13.2 The Meeting noted the Appeal decision ref DC/17/03945 dismissing the appeal against Mid Suffolk's refusal of Planning Permission for the replacement of a roadside hedge with a timber fence at Southacre, Rattlesden Road.

That Drinkstone Parish Council conveys to the consortium comprising the householders at nos. 4,6,8 and 12 Cherry Tree Rise in equal parcels by area the land known as the Cheese Wedge at Drinkstone being some 0.11 acres adjacent to the village playing field in the sum of £3,501 as per their offer dated 11.03.18 on

the understanding that the purchasers jointly pay the Council's reasonable legal costs to a maximum of £2,200 net of VAT.
