**20.07.05 5.1** DC/20/02225 – II Planning Application

Construction of new track and hardstanding area for current pig breeding/rearing. New track and hardstanding area to serve relocation of firewood.

Land Adj Ticehurst Farm (in the Parish of Drinkstone), Road Near Ticehurst Farm, Tostock, Suffolk.

Cllr Holborn reported that he had considered the possible impact of the application on existing hedges alongside the western and southern borders of the new track, and Cllr Elnaugh reported her concern about the possible risk to a young oak tree.

In reaching its determination on this application, the parish council considered:

- the application & supporting documents on the Mid Suffolk planning portal
- Drinkstone neighbourhood plan as submitted to and approved by the examiner

and determined not to object to the application and asked that the following conditions be attached:

1. Protection and retention of the existing hedges alongside the western and the southern boundaries of the new track. Gaps in these existing hedgerows to be replanted with native species and maintained for a period of not less than 3 years

2. If SCC Highways require improvement of the existing access off Tostock road that involves removing any of the existing roadside hedge then in accordance with policy DRN 9 of The Drinkstone Neighbourhood plan approved by MSDC on 8th June 2020 "A new hedgerow of native species shall be planted on the splay returns into the site in order to maintain the appearance and continuity of hedgerows in the vicinity."
